technical (session or navigation) cookies	They ensure the normal navigation and use of the website and are therefore aimed at mainstreaming and optimizing the navigation within the site.
third-party analytical cookies (e.g. Google Analytics)	Coelme S.p.A has adopted appropriate tools to ensure that data processing with these cookies is carried out for statistical purposes only.
